

SUMMARY ANNUAL REPORT
FOR INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS
DISTRICT NO 9 PENSION PLAN

This is a summary of the annual report for the International Brotherhood of Electrical Workers District No. 9 Pension Plan, E.I.N. 93-6074829, Plan No. 001, for the year ended March 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$74,985,246. These expenses included \$1,822,756 in administrative expenses and \$73,162,490 in benefits paid to or for participants and beneficiaries. A total of 30,494 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$1,939,532,825 as of March 31, 2023, compared to \$2,024,259,086 as of April 1, 2022. During the plan year the plan experienced a decrease in its net assets of \$84,726,261. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year. The plan had a total loss of \$9,741,015 including employer contributions of \$122,791,895 rollovers of \$686,332, and losses from investments of \$133,219,242.
